#### **VARIANCE ADDENDUM LIST**

A Variance Request must be **SUBMITTED IN ADVANCE** of any changes to building exteriors. If you have any questions regarding these or any other aspect of the variance process, please contact a board member or our Management Company.

## Specific Item requirements include:

- Full view white storm door on front of units
- Required White Wayne Dalton Steel Gauge garage doors, (with or without windows). If door with windows is chosen, windows must be in the third panel. (As of September 2012, the following venders supply Wayne Dalton Garage doors Felluca Garage Doors (585-467-2391) and Precision Garage Door Service, Inc. (585-2238960).
- Clear glass block windows must be used for basement windows
- Outdoor type electrical outlets
- For Satellite Dish (<u>Please see separate Satellite Dish Variance Form</u>) Cable or dish wires may not be left exposed on any unit exterior walls. To insure compliance by the cable company, please notify superintendent to meet when cable install person arrives

### Other Requirements include:

- All patio area floor or base surface repairs /renovations must leave at least a 6 inch clearance next to all buildings & common shared fences.
- New furnace /hot water heater exterior exhaust installs are preferred to exit into unit patio areas whenever possible & require prior variance approval.
