## Financial Report – Month ending July 2025

Total Operating Income \$66,038; \$5,885 more than budget

Assessment Collections for July were \$951 more than budget

Assessment Collections year to date: \$1,368 less than budget

Total Monthly Operating expenses: \$53,835 was \$834 less than budget

Delinquent Accounts (24) totaling \$10,345

Unfavorable expense budget variances greater than \$100: payroll expense-maintenance, repairs and maintenance, fertilization contract and legal and professional

Favorable expense budget variances greater than \$100: trash removal, maintenance supplies, other landscaping, other administrative and insurance

Maintaining existing allocations to reserve account as per prior fiscal year

Reserve expenditures in July 2025: None. Total reserve expenditures for fiscal year in 2025 is \$6,071.50

On year-to-date basis, net income from operations is \$20,304, which is \$3,669 better than budget.
